The book draws on the ideas of British and American cultural theorists alongside German thinkers such as Heidegger and Adorno, and develops a new conception of cultural ecology explaining the role which writers have played in articulating and shaping conceptions of nature and naturalness, and the input of cultural discourse into environmental debate. The influence of Goethe and the Romantics,

Schopenhauer and Nietzsche, Monism and the Life Reform Movement are traced in green thinking, and attention is given to the political implications of the reconfigurings of their ideas.
